## The Pastor's Pen

I would like to take a moment pause in gratitude for the last year we have shared together.

In January, some members of the Youth Group began a ten-week long Confirmation Class that brought six of our young adults into a more active and permanent relationship with some of the adults in our congregation. Through the first half of February, you filled the bags for Valentines for our very deserving young children, to remind them that you love them and care for them. Also, that month, we celebrated our first Preschool Sunday, what we hope to become a tradition in our year.

In March and April, we journeyed through the season of Lent, in preparation for a Resurrection Sunday unlike any we have had (at least in recent memory). The way you spent that Sunday caring for one of our own and for his family in his recovery spoke about what resurrection really looks like and the love that God gives us to pull each other through difficult and trying times.

In May, we worked together for the Missions Golf Tournament—a day of great joy and play to benefit five well-deserving agencies in our community. By the end of the month, we said, “Goodbye,” to our friend, the Rev. Anthony Lamourt, as he departed from us as Music Minister for health reasons. In June, we began a season of rest by commemorating the life of young Bentley Marlowe and his family at the dedication of a new piece of playground equipment in his memory.

We welcomed July by concluding our search for our new Director of Music Ministries, as we welcomed Dr. Hanna Lee to come be a part of our legacy. August saw us winding down the summer and preparing for the “-bers,” but not before the true take-off of our Lemonade Ministry, instigated by one of our recently-confirmed Youth who wanted to us to be a place of hospitality in the hot summer.

September arrived at Rally Day with our detailed conversation about education in our church

and explanations about our Capital Campaign to update our Sanctuary for 2025. We heard the choir sing music in Hawai’ian as we raised nearly \$4000 for mission work for their recovery. October and November featured wonderful opportunities of in-person fellowship throughout the church during Wonderful Wednesdays and Sunday offerings. December came quickly, and we reintroduced ourselves to the Statesville cultural scene by our Christmas Concert.

Needless to say, 2023 was a prolific and busy year at the FPC, Statesville. God alone knows what the next year will bring us, but so long as we journey together following the verse our dear friend, Ann Sharp, valued in her life—Micah 6.8—we will continue being a congregation which cares inwardly that we might serve outwardly... and that is a beautiful thing.

# Session Notes

At the 18 December 2023 Stated Session meeting, Session:

- Received a devotion from Sloan Goforth about gratitude in the season of Advent and Christmas to come;
- Approved minutes from the Stated Session meeting / Annual Retreat of 19 August 2023 and the Stated Session meeting of 16 October 2023;
- Examined and received Brenda Vernon into membership in the congregation;
- Received a verbal Moderator's Report with discussion on seven topics:
  1. Appointments (a request for family and friends to make appointments with the Team members [Jeremy, Hanna, Falon, LeighAnn, & Clare] to help us to have more efficient use of our schedules);
  2. Committee Calendars (a request to supply the office with accurate meeting dates so they can be properly communicated to the congregation);
  3. Team / Staff Updates
  4. Capital Campaign (a request for Finance & Stewardship to prioritize determining the funding of the Capital Campaign);
  5. Committee Presence (a request for committees to be more active and communicative in the life of the church with members sharing in the church's work);
  6. 2024 Budget (a request for committee chairs to turn into Finance & Stewardship their budget requests); and
  7. Communication (a request for the Ruling Elders to help us determine effective ways to communicate across the congregation; we have heard from several people that we could improve communication from the church, so we want to investigate how better to do this);
- Approved a motion to return to monthly Session meetings, to be held the first Monday of each month (holidays will push to the second Monday), excepting the months of July and December.
- Received the Treasurer's Report, indicating improvement for revenue through November 2023 and a hope that December's offerings will be stronger to finish the year;
- Approved a Consent Docket for the Service of Witness to the Resurrection for Ann Brady and to note her death in the membership record;
- Approved a motion from the Property Committee to upgrade the existing video monitoring system and cameras at an expense of \$10,773.37 with the source of money to be the unused portion of the Food & Fellowship line-item for the kitchen oven update;
- Approved a motion from the Property Committee to develop a new policy: "The FPC, Statesville will not permit use of nor will lease its grounds or facilities to be used by any outside business or individuals to operate a business, whether it be not-for-profit or for-profit. This policy does not prevent any business or agency from performing services or events in conjunction with using the church grounds or facilities in line with the mission/s and ministry/ies of the FPC, Statesville";
- Directed the Property Committee to take on the work of the Building Usage Sub-Committee with input to come from other committees in the development of the Building Usage Policy;
- Requested all active REs to be present for communion during the Christmas Eve Candlelight Service;
- Nominated and approved Sloan Goforth and Nate McElwee to represent their RE Class on the Endowment Board;
- Received a report from the Missions Commission that Pharos Parenting was selected as the 2024 Missions Grant Award recipient;
- Updated the church membership list to reflect requests since 16 October 2023, and
- Prayed for members of the congregation and the present Ruling Elders.

The next Stated Session meeting is scheduled for Monday, 5 February 2024 with Nate McElwee leading the devotional and prayer.


